Recognition Order

Whereas in terms of Section 14(1) of the NCTE Act, 1993, B M College, Plot No. 369/3, 370/3, Balod Road, Vill - Kolihapuri, Durg, Chhattisgarh - 491001, (Code No. WRCAPP1090) had submitted an application on 04.10.2010 to the Western Regional Committee of the NCTE for grant of recognition of B.Ed. course with an annual intake of 100 seats.

And whereas, the WRC considered the matter in 148th meeting and decided to constitute an inspection team for causing inspection of the institution.

And whereas inspection of the institute was conducted on 17.05.2011.

And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution has adequate financial resources, accommodation, library, laboratory and that it fulfills such other conditions required for proper functioning of the institution for B.Ed.course, as determined by clause 7(9) of NCTE Regulations, 2009, and decided to issue letter of intent dt. 22.06.2011.

And whereas, reply dt. 07.07.2011 submitted by the institute was considered by WRC in its 152nd meeting and committee decided to issue Show cause notice vide letter dt. 17.09.2011.

And whereas, reply dt. 23.09.2011 submitted by the institute was considered by the WRC in its 157th meeting and committee decided to seek clarification. A clarification letter was issued to the institution vide dt. 06.02.2012.

And whereas, reply dt. 03.03.2012 submitted by the institute was considered by the WRC in its 165th meeting and committee decided to seek clarification. A clarification letter was issued to the institution vide dt. 11.07.2012.

And whereas, reply dt. 03.07.2012 submitted by the institution was considered by WRC in its 167th meeting and committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified staff, laboratory and that it fulfills such other conditions required for proper functioning of the institution for B.Ed. course, as determined by NCTE Regulations 2009.

Now, therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to B M College, Plot no. 369/3, 370/3, Balod Road, Vill - Kolihapuri, Durg, Chhattisgarh - 491001, (Code No. WRCAPP1090) for starting B.Ed. course of Secondary level of 1 year duration with an annual intake of 100 from the academic Session 2012-13.

Further, the institution is required to comply with all post-recognition conditions enumerated from clause 8(11) to clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations 2009.

The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.

The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009 for the academic session 2012-2013.

The recognition will operate for 2012-2013 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.

If, at any time, either on sue-motto inspection or on any representation received from any person, the WRC, NCTE is satisfied that the institution has contravened any of the provisions of the NCTE Act, or the Rules, Regulations, Orders made or issued there under or any condition subject to which the recognition was granted, the recognition may be withdrawn under the provisions of section 17 (1) of the NCTE Act.

Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the B.M. College, Plot No. 369/3, 370/3, Balod Road, Village- Kolihapuri, District- Durg, Chhatisgarh - 491001 by affidavit dt. 07.01.2015 has consented to come under new Regulations and sought for two basic units in B.Ed. which require additional facilities

3. And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the **NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to B.M. College, Plot No. 369/3, 370/3, Balod Road, Village- Kolihapuri, District- Durg, Chhatisgarh - 491001 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.**

5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution:
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter:
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. Recognition order no. WRC/APP1090/167th/B.Ed./2012/93877-93884 dated 08.08.2012 be treated as cancelled from the date of issue of this revised order.
